

# 15th Ave W/NW and Ballard Bridge Paving

November 2022

## FREQUENTLY ASKED QUESTIONS

### Why do we need to do this project and how did this get chosen?

Each year, we pave arterial streets in poor condition to make them safer, smoother, and to extend their useful life. We prioritize paving based on pavement condition, traffic volume, geographic equity, cost, and opportunities for grants or coordination with other projects in the area. Keeping our transportation system in a good state of repair helps lower the cost of future maintenance. Like many of our arterials, it's important to maintain them since they are primary routes for moving people and goods through the city and connecting neighborhoods and business districts to one another and the regional transportation network. 15<sup>th</sup> Ave W/NW and the Ballard Bridge is one of the City's most heavily used arterial streets. Repaving 15th Ave W/NW (from NW 57<sup>th</sup> and W Emerson St) and the approach spans for the Ballard Bridge will restore the pavement condition of a critical piece of Seattle's arterial network. This project also contributes to SDOT's Levy commitment to pave up to 180 lane-miles of arterial streets by 2024.

### How will construction impact my commute?

We are currently in the planning phase of the project and as such, we're still determining the details of construction. Details may include: starting locations, work hours (including nights and weekends), the potential for detours, and road closure times. We are committed to continually share more information about the project as it becomes available. In general, typical construction activities include:

- Temporary lane and street closures for people driving
- Temporary sidewalk and crossing closures and detours for people walking and rolling
- Temporary vehicle detours
- Temporary bus stop relocations
- Disruptions to on-street parking
- Noise, dust and vibrations during work hours
- Construction staging and parking impacts near the work sites
- Changes in construction schedule due to unforeseen circumstances (i.e., weather, soil conditions, etc.)

### When will you be starting to work on this paving project and when do you expect it to end?

We expect to start construction as early as the Summer of 2023 and anticipate construction being completed by Fall 2024. Schedules are always subject to change due to supply availability and inclement weather.

### What do we need to do in case of an emergency near the project?

If there are any emergency situations that arise in our project area, please call 911. Access for emergency vehicles will be maintained at all times during our work. ### Will the Leary Way Bridge seismic project extend the timeframe of construction on 15th Ave NW?

The [Leary Way Seismic Retrofit project](#) is scheduled to follow the same timeline as the 15th Ave W/NW and Ballard Bridge Paving project and will not extend the timeframe of construction.

### **Why are you doing Leary Way Bridge Seismic Retrofit project at the same time as this paving project?**

The location of the [Leary Way Seismic Retrofit project](#) overlaps with the 15<sup>th</sup> Ave W/NW and Ballard Bridge Paving process. The Leary Way Bridge is located just north of the Ballard Bridge, on 15<sup>th</sup> Ave NW over NW Leary Way. We are combining the projects and completing them during the same timeframe to minimize construction and traffic impacts.

### **Will this project require businesses to close during construction?**

Businesses in and around the surrounding project area will be able to remain open and entrances will still be accessible. We encourage neighbors to continue shopping and using their services. We are committed to working with business owners and staff to address their concerns and potential construction impacts.

### **Will this project replace the Ballard Bridge?**

This project will not replace the bridge. We will be repaving asphalt along 15<sup>th</sup> Ave W and NW (between NW 57<sup>th</sup> and W Emerson St) up to the metal grates (bascule) of the bridge. While we complete the repaving of the bridge, we will also include maintenance and repairs to the bridge deck. This will preserve the life of this critical piece of infrastructure and support the safety and mobility for the traveling public.

### **Do you plan to close the Ballard Bridge?**

We aim to maintain one lane in each direction at all times during our construction and do not have plans to fully close the bridge. We will be looking at ways to mitigate traffic impacts such as targeting specific times of the day and nights to do this work so it's less impactful to commuters and surrounding neighbors.

### **Will this project improve bike facilities on the Ballard Bridge?**

Bike facilities on the Ballard Bridge are outside the scope of this project. This project is focused on the preservation of our existing infrastructure and not building new infrastructure. We understand and acknowledge that the Ballard Bridge is a key north-south connection across the Ship Canal/Salmon Bay for people biking, and all modes of transportation. ### **Will my bus route be impacted by construction?**

There may be temporary bus stop relocations during construction. We will do our best to provide notice about any upcoming bus service changes, but we also recommend you sign up for King County Metro's [Rider Alerts](#) to stay up to date on the latest information

### **How does this impact the future Sound Transit Light Rail project coming to Ballard?**

Paving on 15<sup>th</sup> Ave W/NW and Ballard Bridge and the Sound Transit Light Rail line in Ballard have different timelines and scopes of work. This paving project does not anticipate conflicting project designs or construction impacts to the Ballard Light Rail line. As we move forward with our project, we will continue to coordinate with Sound Transit if any changes arise. ### **How are you communicating with residents and ensuring this project is responsive to community needs?**

We will communicate with neighbors throughout the design and construction phases of the 15<sup>th</sup> Ave W/NW & Ballard Bridge Paving Project. Planned efforts include calling key stakeholders, delivering project information to nearby businesses and residents, and meeting with neighborhood groups to learn how we can best accommodate travel needs and minimize construction impacts.
