

6th Ave W Access and Habitat Improvements

Project Overview

Description

We are proposing improvements to the 6th Ave West shoreline street end located at 3601R 6th Ave W. This project will provide public access and shoreline habitat improvements along the south shore of the Lake Washington Ship Canal. The initial proposal includes the following improvements:

- Replace the informal parking spaces along the shoreline with habitat and pedestrian amenities
- Regrading of the shoreline to create an expanded beach area
- Installation of anchored logs and native plantings to help protect the shoreline from erosion
- Installation of native landscaping, gravel beach, and enhancement of an existing swale
- Installation of informal seating elements such as a flat top logs and boulders
- Installation of a walking path from the South Ship Canal Trail to the street end. The path will be located on the existing asphalt surface, protected by parking block curbing, and striped to indicate pedestrian use only
- Regrading of the surrounding area to direct stormwater to an existing swale
- Repair of potholes at the intersection of 6th Ave W and W Ewing St

So far, we have completed a survey of the site and kicked off the design process. Our current estimate is that these changes will be completed in either the summer or autumn of 2023. As details of this project become available, we will share information with the community.

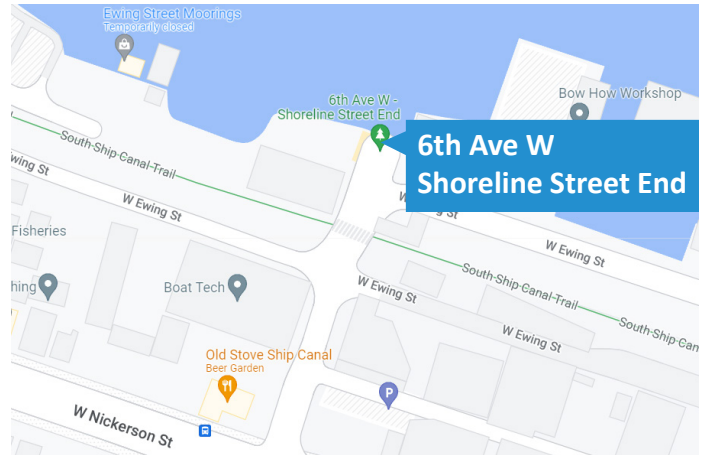

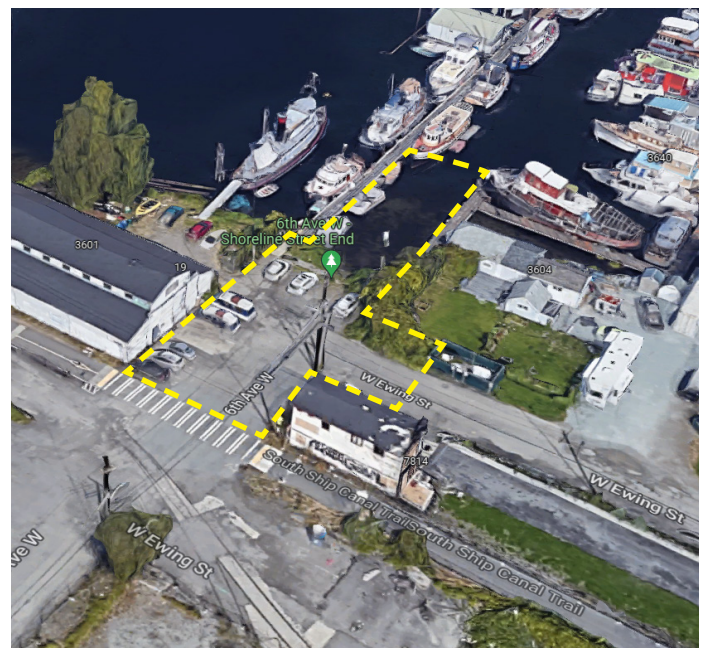
